REGULATION Z – CONSUMER CREDIT TRANSACTIONS THRESHOLD AMOUNT

The Board of Governors of the Federal Reserve System and the Consumer Financial Protection Bureau have issued final rules pertaining to the implementation of the Consumer Protection Act (CPA). Effective January 1, 2023, the threshold for exempt consumer credit transactions increased from \$61,000 to \$66,400.
