## 108TH LEGISLATURE CONVENES

The 108th session of the Nebraska Legislature convened on Wednesday, January 4, at 10:00 a.m., with the initial day of the session featuring the election of committee chairs and appointment of individual members to legislative committees. Sen. John Arch (Omaha) was elected to the position of Speaker of the Legislature. The following new committee chairs were also elected by their colleagues:

The first 10 working days of the session will be devoted to new bill introductions. During the first two days of bill introductions, a total of 145 bills and seven proposed Constitutional Amendments were dropped into the hopper. Committee hearings are tentatively scheduled to commence on Monday, January 23. It is anticipated that the following major issues will dominate the session: the state budget, property and income tax relief, and revisions to the school funding formula.

The NBA will be promoting an ambitious affirmative legislative agenda with a number of bills to be introduced on behalf of the Association. These bills will cover a range of subjects, including: (1) UCC Article 12-Security Interest in Digital Assets; (2) Assignment of Life Insurance Policy-Notice of Lapse; (3) Trust Deeds-Location of Sale; (4) Small Estate Affidavit-Endorsement of Checks; and (5) Repeal Annual Reporting of Executive Officers' Outside Indebtedness.

It is anticipated that each of the bills on the NBA Affirmative Legislative agenda will be introduced during the first full week of the session, and we will provide more specific information on each of these bills at that time.
