

# PREFERRED CENTERS

BCBSNE will waive the deductible and coinsurance amounts\* for the facility charges for the following surgeries performed at one of the Preferred Centers listed below:

- Dorsal and lumbar fusion (except for curvature of the back)
- Cervical spinal fusion and other back/neck procedures
- Total hip replacement
- Total knee replacement



Preferred Centers are surgical facilities recognized for high-quality care, including high patient satisfaction, low readmission rates, low infection rates and lower costs. Blue Cross and Blue Shield of Nebraska will waive deductible and coinsurance amounts\* for the facility fees for members of participating plans who have total knee or hip replacement or spine surgeries done at one of these hospitals.
