

## BASIC SPOUSE/DEPENDENT GROUP TERM LIFE INSURANCE

*Spouse/Dependent Life Insurance is underwritten by The Standard Insurance Company*

The Basic Spouse and Dependent Life Insurance is a blanket policy and automatically covers all eligible family members from initial enrollment.

### Schedule of Benefits

Spouse Insurance benefit:	\$2,500
Children (live birth to age 26):	\$2,000

### Eligible Dependents:

- Spouse
- Children, including natural born, step, and legally adopted to age 26.

### General Information

- Enrollment in Dependent Life is available with enrollment in Basic Life/AD&D.
- If you apply for coverage more than 31 days after becoming eligible, you **must provide** and **have approved** evidence of insurability.

### Plan Features

- **Group Life Portability and Conversion Provisions:** If spouse and/or dependent group life insurance ends because of employee termination or loss of eligibility, the spouse can port (buy) or convert their group life insurance. (See back side for additional information.)

### Premium

- Premium is \$1.97 per month  
*(If the institution pays premiums, this could become taxable income to the employee).*

Eligibility	Members may purchase life portability insurance (including AD&D) on the date their <b>employment terminates</b> . <b>Disabled members are not eligible.</b>	Members may purchase life conversion insurance (not including AD&D) on the date they have a <b>loss in coverage</b> . <b>Employee CAN be Disabled.</b>
