Help NBEF Reach **\$1 MILLION** And Fund More Scholarships!



Thanks to the ongoing and generous donations of our member banks and bankers, NBISCO, and NetWorks, the NBEF William B. Brandt Memorial Scholarship Committee has awarded nine \$2,000 college scholarships for the 2018-2019 school year. Since 2002, the Nebraska Bankers Educational Foundation (NBEF) has awarded 166 college scholarships worth a total of \$201,250.

In 2014, the NBEF Board of Directors announced a drive to bring the fund to \$1 million, so more students can benefit from scholarships.



Through this scholarship program, we honor William B. Brandt for his service to the banking industry, his community, and the state of Nebraska.

In conjunction with the fund drive, the Brandt family made a \$25,000 donation to NBEF. In addition, John Stinner and Western States Bank in Gering pledged \$25,000 over five years. The challenge is for NBA members to match the Brandt family contributions and help NBEF reach \$1 million.

Several past scholarship recipients are now working in Nebraska financial institutions, accounting firms, and other financial services-related organizations. "This clearly demonstrates the foundation's success in accomplishing one of the most important goals of these scholarships—to attract and retain the best and brightest students in Nebraska," said NBA President & CEO Richard Baier.

The Nebraska Bankers Educational Foundation (NBEF) is a non-profit corporation organized exclusively for charitable and educational purposes. One of its primary goals is to award scholarships to junior- or senior-level students majoring in bank-related programs at state or privately funded colleges and universities (excluding the University of Nebraska).
